### **Nigel Bankes (seeking re-appointment)**

Nigel Bankes is an emeritus professor of law, having retired from the University of Calgary in 2021. Nigel spent much of his career working in the areas of energy and natural resources law, as well as international environmental law. Elliot enjoys being in the mountains with his family, hiking, hunting, fishing, relaxing and exploring and is passionate about maintaining wild places and spaces in Blackfoot Territory and advocating for the return of plains bison and native trout and large carnivore restoration.
